**Must apply online or by calling IVLP at: (208) 334-4510, or 1-800-221-3295 --Toll free, Idaho only. Hours of operation: 8 AM to 5 PM, Mountain Time, Monday through Friday.

Types of cases IVLP can take:

- Custody and Visitation
- Divorce (Limited--Contact your local crisis center if you are the victim of domestic violence)
- Modification of child custody court orders

IVLP cannot take:

- Child support collection
- Defense of child protection cases
- Defense of protection order cases
- Paternity cases

- 3) **Idaho Lawyer Referral Service**

The Lawyer Referral Service (LRS) is operated as a public service of the Idaho State Bar. The LRS attorneys have agreed to provide their clients with an initial \$35 half-hour office consultation fee. After initial half-hour, any further fees are to be negotiated between the lawyer and client. The Idaho State Bar does not charge the public for these referrals and receives no money from the attorneys for the referrals. All attorneys listed in either

the online or call-in LRS database have paid a fee to participate in the LRS. Not all Idaho State Bar attorneys are members of the LRS service.

- **To call outside King County:** Call 1-888-201-1014 weekdays from 9:10 a.m. until 12:25 p.m. CLEAR works with a language line to provide interpreters as needed at no cost to callers. If you are deaf or hard of hearing, please call 1-888-201-1014 using your preferred TTY or Video relay service.
- **King County:** Call 211 for information and referral to an appropriate legal services provider Monday through Friday from 8:00 am – 6:00 pm. You may also call (206) 461-3200, or the toll-free number, which may be useful when calling from a pay phone, 1-877-211-WASH (9274). 211 works with a language line to provide interpreters as needed at no cost to callers. Deaf and hearing-impaired callers can call 1-800-833-6384 or 711 to be connected to a relay operator at no cost, who will then connect them with 211. Information on legal service providers in King County may also be accessed through 211's website at www.resourcehouse.com/win211/
- **Persons 60 and Over:** Persons 60 or over may call CLEAR*Sr at 1-888-387-7111, regardless of income. People who call CLEAR*Sr will be asked to leave a message with their name, phone number and whether it is all right to leave a message. The CLEAR*Sr line will close once the voice mail message system is full. Low-income seniors may call the CLEAR line at 1-888-201-1014, from 9:10 a.m. - 12:25 p.m. Also, low-income seniors calling the CLEAR*Sr line at 1-888-387-7111 have the option to transfer to the CLEAR line, and if eligible, may speak with an advocate that day.
