Computer Specialist I (CRC-20-036 Gaming, Full-time) this position is responsible for assisting the MIS Director in the day-to-day management of Information Systems by directly supporting end users and systems in various departments throughout the Enterprises Requires a minimum of two years combined experience in the field of information systems or computer related job environment.
