

Chairman's Report

As Nimiipuu look to the past and remember what exactly our people secured for the future in the year 1855, we must honor "The Way of Life." We all know the Treaty of 1855 guaranteed in perpetuity rights that fall under this vast umbrella. We also know it granted the United States rights as well within our country. It is this moment in time that the Nimiipuu the true administrators of our own territory hold the federal government accountable to hold up their end of the bargain that secures our way of life. This General Council Report will summarize the business Nez Perce Tribal Government has been doing to perpetuate our way of life.

Nimiipuu have always made sure the things most important were at the forefront for all the people. Tribal Government has been one mechanism in place to help when needed in moving such activities toward the future. However, Tribal Government can only go to a certain point, it is the people that carry the weight of exercising this way of life. The people are our makers, singers, diggers, hunters, fisherman, dancers, healers, and a plethora of other titles. When we as a people look to continue this way of life it includes many facets. We have our cultural, spiritual, and traditional healing ways. We also have our modern ways that are evident in our everyday life, technology, science, and math. We are very fortunate the creator has placed us Nimiipuu in this beautiful area that allows us to be diverse. For it is truly the gift of the creator to live amongst some of the most beautiful creations.

Our people have also been in the middle of an economy that was so large and vibrant and as a good friend has put it "beyond modern conceptual ideology of wealth." That is who we are and the history books tend to leave the wealth piece out of the teachings. When we look to combine the past & present we find many parallels that we must balance for the future generations. The balance must be an understanding the need to diversify our revenue sources, evolve with the times, all the while expanding our traditional way of life. To do more with less and place the life sources we depend on as our highest priority. It is this balance we are working diligently to achieve through numerous departments and interactions with the people.

Salmon, Steelhead, Lamprey, Energy, Technology, Land and Water have been high on the list of movement within the tribal government. Each of these activities have generally involved federal, state and local governments, as well as agencies from each of these entities. Let's take a look at what has been happening.

- We are of this land. We are of these waters. Salmon, steelhead, and lamprey they connect us to these lands, these waters, and these ecosystems. They connect us to time immemorial. They connect us to our 1855 Treaty. They connect us to all of our people. They connect us to all our leaders who have gone before, and whose wisdom and work we build upon. And, they connect us to our future generations, and to what it means to be Nimiipuu. They are our food sovereignty. They are our economy. They are our way of life. They are our future.
- We have always been entrusted to be their stewards and to be their voice when they need it most.
- They tell us to speak the truth!
- They tell us to emphasize what is obvious restoring the Lower Snake River is urgent and overdue.

- They tell us to emphasize what we know that the Lower Snake River is a living being a life force—that needs to be restored.
- They tell us to continue to advance our vision for the future and to implement that vision now.
- As Nimiipuu, salmon, steelhead, and lamprey are a part of our heart and we are at the heart of all the efforts to restore them.
- Our leadership, in every forum, is focused on restoring salmon, steelhead, and lamprey and building alliances around their recovery.
- Our efforts are tireless. Our voice is being heard. And, we're achieving results.
  - We, along with the state of Oregon and our conservation group allies, have ensured that the Tribe's voice of truth is heard in the courtroom.
    - Judge Simon, of the Oregon District Court, agreed with the Tribe in his 2016 ruling that the Federal Columbia River Power System "cries out for a new approach if wild Pacific salmon and steelhead, which have been in these water since well before the arrival of homo sapiens, are to have any reasonable chance of surviving their encounter with modern man."
    - Following Judge Simon's ruling, and his granting of the relief we supported of spilling additional water at the dams to aid juvenile migration of salmon, we had expected that the Columbia River System Operation Review Environmental Impact Statement (EIS) would state the truth when it comes to the impact of the Lower Snake River dams on salmon and on tribal people.
    - When, even after the Tribe's participation, this EIS attempted to bury breaching the Lower Snake River Dams and attempted to ignore our Treaty rights, we made sure that the record would document the heavy burden these concrete barriers in the Lower Snake River have inflicted on salmon, steelhead, and lamprey and on us impacting our culture, our livelihoods, our very way of life, and what it means to be Nimiipuu.
  - We conveyed this reality to Bonneville Power Administration, the Army Corps of Engineers, and the Bureau of Reclamation in our formal comments this spring, and in consultation meetings this fall as they were finalizing the Environmental Impact Statement and Record of Decision.
    - We have called it like it is with these agencies that operate the federal dams—and with NOAA Fisheries—in our Government-to-Government consultations. We have emphasized that the federal agencies' job is to tell the truth when it comes to the impacts the federal dams—and the lower Snake River dams in particular—have had on salmon, steelhead, and lamprey; our Treaty rights; and our people.
  - O We've continued to refuse to be "bought off" by some sort of Memorandum of Agreement or Accord with the federal agencies. In September, we politely declined the federal agencies overtures, indicating that our focus remains on restoring Snake River salmon, steelhead and lamprey and restoring the lower Snake River by breaching the four lower Snake River dams and investing in local communities.
  - Because we speak the truth, the federal agencies' respect for the Nez Perce Tribe has increased.

- We've reached out to our sister Tribes the Umatilla, Yakama, and Warm Springs—in recent months to emphasize that our unity lies in focusing on recovery of salmon, steelhead and lamprey.
- And, we've begun reaching out to the other tribes in the basin to build alliances
  of a common vision for a restored Lower Snake River, and for actions to address
  the lack of salmon these tribes in blocked areas have suffered.
- We've participated in "energy and salmon" groups to educate the energy interests about our vision of the "old money" in the region salmon, steelhead, and lamprey and how they need to embrace and accommodate our vision.
- We are encouraged that the region, through the Columbia Basin Partnership, has acknowledged that we all want to have healthy, abundant, harvestable levels of salmon.
- And, thanks to the work of Joe Oatman in Idaho Governor Brad Little's salmon workgroup, we've seen all interests in Idaho embrace the goal of abundant, healthy, harvestable salmon.
- As Nimiipuu, we know leadership when we see it.
  - We appreciate the leadership Idaho Congressman Mike Simpson has shown in emphasizing what we've been saying for a very long time we want to have healthy, harvestable salmon returning to the Snake River basin and we need to do what it takes to ensure that occurs for our future generations.
  - Leadership like Congressman Simpson's presents real opportunities. We are continuing to work with him and other members of Congress, emphasizing the need to act now, especially in light of a warming climate.
  - We've seen leadership from Governor Brown in acknowledging the importance of breaching the lower Snake River dams.
  - We've seen leadership from Governor Inslee in Washington's study of breaching the lower Snake River dams, and the acknowledgement that the impacts of those dams on the Tribe were front and center.
  - We've met directly with Governor Little to emphasize the need for leadership.
  - o And, we'll be educating Governor Gianforte along the same lines.
- As we look forward, we will continue to do everything that salmon, steelhead and lamprey need across all branches of the federal government.
  - o We are prepared to pursue another round of federal court litigation with our allies.
  - We are actively –daily—engaged in discussions with Congressional leadership.
  - And, we are working to ensure the new Biden/Harris Administration—who has emphasized telling the truth, following the science, and respecting Tribal rights and sovereignty—understands the urgent need to restore salmon, steelhead and lamprey.
- We view the coming months as a time of opportunity for salmon, steelhead, and lamprey and for the Nimiipuu.
  - As we continue to advance restoring the lower Snake River, we will continue to speak for salmon, steelhead, and lamprey to honor them, to honor all of our leaders who have gone before, and to honor all of our future leaders.
- "The Tribe continues its fight against Midas Gold's proposed Stibnite Gold Project. Located at the headwaters of the East Fork South Fork Salmon River within our beautiful homeland, the Project is an enormous open pit gold and silver mine that will destroy our

fish, ruin our habitat, and threaten our treaty rights for decades to come. The Tribe continues to actively pursue litigation in federal court against Midas Gold for illegal pollutant discharges at the Stibnite site. We also recently submitted comments on the Forest Service's environmental review of the Project. The comments were over 125 pages and documented the many significant problems the Tribe has with the Project and the Forest Service's evaluation."

As many may know the Nez Perce Tribe has moved forward with our first step into becoming energy independent through the deployment of solar power and storage through light commercial and residential scale systems. The project also created a workforce training and development for tribal members in facets of renewable energy education to include design, engineering, and installations of solar panels and Tesla energy storage packs. We know that sustainability and resiliency must happen for our future generations to thrive. This project also looks to saving Salmon, Steelhead and Lamprey. How one might ask? We know the 4-Lower Snake River Barriers create around 3000 megawatts of electricity. It is up to the other renewable energies like solar and wind to offset those megawatts so breaching can occur. For every megawatt produced we are that much closer to making the argument for dams disappear. We look for this technology to lead us into the future.

The Nez Perce Tribe has also advanced our communications capabilities to a new high. The need to be able to connect in today's world is of utmost importance. The current pandemic we are in is a true testament as to the need of investing into our future.

- 1) The Nez Perce Tribe invested in fiber from Spaulding to the Port of Whitman in Clarkston giving necessary backhaul to the Tribal operations. This 21 miles of fiber will provide future expansion for enterprise development. The casino will have expanded connectivity and is connected to the fiber. Surveillance will also have expanded connection independent of the casino connection to expand service into Kamiah. The extra strands will be leased to independent companies and will reimburse the Tribes investment.
- 2) The Nez Perce Tribe was awarded a \$2 million dollar fiber grant from the State of Idaho. This grant will run fiber in locations around Lapwai. This project will be completed by mid-December. We anticipate that this will connect up to 300 homes when completed. The State has included future projects for other towns on reservation in future funding requests for broadband development in the State.
- 3) The Tribe was awarded their 2.5 GHz license for coverage over the reservation. This will upgrade our wireless network. These upgrades are underway, and much of the equipment has already been ordered. This will give us faster speeds over our wireless network. This spectrum license was a significant step, giving us rights to our airwaves over our reservation.

The Land that provides for us is important, for we utilize the lands for gathering, agriculture, spiritual and cultural purposes. It also provides revenue for the Tribe. For all of its uses it also speaks to us about the changing climate. The Tribe is currently developing a Climate Change Vulnerability Assessment and Adaptation Plan and will be working with the University of Idaho on project development of dataset and tools to inform decision making for vulnerabilities to our

tribal resources and assisting resilient land use plan. The Department of Natural Resources is heading up this project through the Climate Change/Energy Sub-Committee and has accepted grant funding to help in the managed retreat, expansion, protect-in-place, and relocation options. As we study the lands we can best determine sufficient uses for allowing its resiliency to thrive.

These lands are also being considered for revenue generation in areas other than dryland farming. The Tribe is in the midst of a feasibility study to determine the cost of grape production on designated lands identified as suitable for production. The Tribe entered into a contract with Garcia Contractors, Inc. this past April to diversify its land holdings. Most of the land in our agricultural management is for dryland farming and held in trust by the Bureau of Indian Affairs. Our revenue generated is based upon a one third crop share or cash rent lease agreement with non-Indian farmers.

The Tribe is sole owner of a trust land parcel, comprising of 72.8 acres, located on the Reservation Line Road at Mann Lake. We have entered into a one-year lease agreement for dryland farming to allow for the possible transition of this property to viticulture use. When the Lewis Clark Region was designated as an American Viticulture Area (AVA) designation we opted to look at developing this site for as a wine grape vineyard. We chose Garcia Contractor's to assist us with the planning and layout of the site.

The feasibility of the project is underway. It is our intent to move forward with plans to convert the property into a vineyard for wine grape production that can be sold to the local winery's or as part of a larger goal to produce our own wine. The numbers to this point look promising as to increase what would be a hundred dollar an acre dryland to a significantly larger dollar per-acre irrigated farmland.

The Tribe also are taking the necessary steps to put in place the ordinance and regulations so our tribal membership can produce Hemp. The new ordinance that will govern hemp production on the reservation was sent through sub-committee and sent out for public comment for 30-days. The tribe received comments and are going through them currently. Once the process is complete it will be sent to the U.S.D.A. for final approval and operations can begin. The U.S.D.A. will have 60 days to complete the approval and sent back to the Tribe. The Nez Perce Tribal Enterprise also sees an opportunity to diversify the business holdings for the Tribe through planning and development of new business units. The Nez Perce Tribal Enterprise Research and Development has completed a preliminary feasibility study to analyze the potential for the establishment of a tribal agriculture enterprise to engage in dryland farming and conversion of tribal owned land to irrigated cropland for producing specialty crops, and other agriculture products.

Much of this hinged on the development of a tribal water code which has since been developed and approved by the tribe and is still awaiting approval of the Department of Interior. We are told we are just one signature away from receiving this approval.

All of this has been happening amidst the Coronavirus Pandemic which has plagued the world and our people. We have had to endure much change in the face of this pandemic. We have a list of activities that has gone on around the Tribe since February of 2020. NPTEC has also focused a lot of time and energy on the Tribe's response to the COVID-19 pandemic. At the federal level, we

have worked hard to ensure the Tribe received its fair share of federal assistance. As a result, the Tribe has received monies from the Coronavirus Relief Fund and the Paycheck Protection Program. Programs such as housing, social services, the clinic, commodity foods and others also received assistance under various provisions of the CARES act. These funds have allowed us to provide direct and indirect assistance to Nez Perce citizens to assist them during the pandemic. We have also been able to update infrastructure and purchase tools and equipment that have helped with our response to the pandemic as well.

We also have participated in weekly calls with the White House and federal agencies including the BIA, IHS, Health and Human Services among others. Coordination and collaboration with other tribes and states has been an important priority during this time too. We have hosted weekly calls with the other tribes in the area as well as conducted regular calls with Governor Little in Idaho and Governor Inslee in Washington state.

Of course, most important is the work of our programs here on the Reservation. I want to thank the leadership and staff of the clinic for working countless hours over the last 8 months to provide services to our people. In addition, tribal staff has worked hard, under difficult circumstances, to continue and provides services to the public with the least amount of interruption. Thanks to all of those who have worked so hard during this time.

We have also been part of the vaccine planning information session for tribal communities and HHS Regional Consultations. We have a delegate sitting on the Idaho COVID-19 Vaccine Advisory Committee to advise the Governor on:

- Prioritizing of vaccines when it is in limited supply;
- Implementation of the vaccination plan;
- Communication and delivery of the vaccine.

As you can see the Nez Perce Tribal Entities have been very involved in doing all we can to help combat the Coronavirus.

When we look back at the last 6-months we know we must continue our efforts in the battle with the Coronavirus. We know we are going to begin a new administration January 20, 2021. We have much hope with the new administration and their views on the environment, social injustice and the Native Communities in general.

As we forge ahead building on the foundations our people have built and creating a strong prosperous, balanced future for all, we must remember that we are all one and work together to create that healthy future as such. Thank you for your time.

Dear Elliot:

I write on behalf of the Nez Perce Tribe to thank you for your service as Administrator and to wish you all the best in your new endeavors.

We appreciate your acknowledgment of the sacred Treaty and trust responsibilities of the United States arising from the United States' 1855 Treaty with the Nez Perce. We also appreciate the respect you have shown for the Nez Perce Tribe's prominent role in all issues involving salmon, lamprey, wildlife, and the ecosystems on which they depend; and for the Tribe's unwavering commitment and leadership on restoring the lower Snake River by breaching the four lower Snake River dams and investing in local communities.

As you have witnessed first-hand, our long-standing partnership with the Bonneville Power Administration in implementing fish and wildlife mitigation throughout the Snake River Basin that includes restoring fish and wildlife habitat and managing hatcheries to provide important fishing opportunities to both non-Indian and Treaty fisheries – important work that will need to continue in the future – is strong, and has benefitted from the direct lines of communication that have been your hallmark throughout your tenure as Administrator.

We appreciate the interest you have shown in envisioning a future that encompasses a restored lower Snake River, and the Nez Perce Tribe's central role in that future. We view restoring the lower Snake River as urgent and overdue, and we are committed to continuing to provide leadership on restoring the lower Snake River in all forums. Unfortunately, the Columbia River System Operations Environmental Impact Statement fails to provide the accurate, complete, and transparent information and analysis of the impacts of the four lower Snake River dams that are necessary for national and regional decision-makers as required by law. And the Biological Opinion – in the face of looming climate change projections – requires no more protection for salmon and steelhead than the 2019-2021 Spill Operation Agreement that was merely intended

as an interim agreement – a bridge – to the development of a more significant system improvement. As a result, the federal EIS and the BiOp present obstacles to Bonneville and others in achieving meaningful, substantive solutions involving restoration of the lower Snake River.

Finally, we have appreciated collaborating with you and your staff, and the Army Corps, on the Phase 1A study of a proposed additional turbine at Dworshak Dam. As you know, the Tribe has a unique status, history, and knowledge with respect to Dworshak Dam and Reservoir. As we communicated to the Corps originally, and then to the partnership that commenced with you as well, the Tribe views the United States – given unresolved U.S. fiduciary obligations to the Tribe from the construction and operation of the dam on the Nez Perce Reservation and the uncompensated use of tribal land ever since – as having a Federal interest in examining the development of additional hydropower at Dworshak Dam through collaborative partnership with the Nez Perce Tribe.

The Nez Perce Tribe continues to focus – in vision and action – on what our people see as core truths: 1) the status of salmon, steelhead, and lamprey is dire; 2) the four concrete barriers on the lower Snake River have had – and continue to have – a devastating impact on the fish and on

tribal people; 3) restoring the lower Snake River to a natural river and eliminating these barriers that stand between the largely-pristine habitat in the Salmon, Snake, and Clearwater basins is the cornerstone to rebuilding returns along with ongoing hatchery and habitat actions; and 4) as dire as the situation already is, these fish may have even less time given the looming impact of a warming climate.

The Tribe does not see an MOU with your agencies at this time as aligned with these core truths. Nor do we see an offer to address and correct the plain flaws of the Columbia River System Environmental Impact Statement and the 15 year Biological Opinion it has been merged with, or to provide additional protective measures for fish (or restore measures for fish deleted from the Proposed Action/Preferred Alternative). Our constant duty is to the Nez Perce people – the *Nimiipuu* – and the vision we maintain of a better future for our people.

The Tribe's relationship with Bonneville, the Corps, and Reclamation is a direct one, established by our 1855 Treaty with the United States, in which the Tribe reserved, and the United States secured to the Tribe, rights – including the right to take fish at all usual and accustomed places – essential to our way of life, culture, economy, and health – physical and spiritual. As two sovereigns, through government-to-government consultation, we have regularly met with you in a spirit of collaboration to address the importance of the United States honoring its Treaty and trust obligations to the Nez Perce Tribe. Under the U.S. Constitution, United States treaties are the "supreme law of the land"; United States treaty and trust obligations to Indian tribes cannot be delegated or passed to the states. Our relationship with Bonneville, the Corps, and the Bureau is strong and sincere. We have found much success together. Our relationship will continue to be strengthened as we, together, directly confront issues with transparency.

As long-standing partners carrying out fish and wildlife restoration against the backdrop of the Northwest Power Act and the Endangered Species Act, the portfolio of work that we will continue to jointly implement in the Snake River Basin will benefit the fish and benefit all peoples throughout the Columbia-Snake watershed. In the course of implementing this portfolio, we routinely discuss priority implementation issues, and elevate larger issues for government-to-government discussion – for example, the need to address aging hatchery infrastructure or concerns with reductions in fish and wildlife funding.

We view restoring the lower Snake River – a living being to us, and one that is injured – as urgent and overdue. We will be providing leadership in all forums: from our discussions with you as our federal agency trustees and partners, to the halls of Congress, to the courtroom, to the statehouses, to conversations with our neighbors, energy interests, and other river users. Our experience is that rarely can one forum operate in exclusion of others, and often litigation plays a constructive role in advancing interest-based solutions.

We look forward to continuing to engage with you on a government-to-government basis concerning the operation of the dams on the lower Snake and Columbia rivers and as partners in implementing fish and wildlife actions in the Snake River Basin.

#### Nez Perce Tribe Calls for Leadership on Lower Snake River Restoration

Core Truths Not Addressed in Federal Agencies' Record of Decision on Dam Operations on lower Snake River and mainstem Columbia River.

Lapwai, ID — Today, the Nez Perce Tribe emphasized that it continues to focus — in vision and action — on what our people see as core truths: 1) the status of salmon, steelhead, and lamprey is dire; 2) the four concrete barriers on the lower Snake river have had - and continue to have - a devastating impact on the fish and on tribal people; 3) restoring the lower Snake River to a natural river and eliminating these barriers that stand between the largely-pristine habitat in the Salmon, Snake, and Clearwater basins is the cornerstone to rebuilding returns along with ongoing hatchery and habitat actions; and 4) as dire as the situation already is, these fish may have even less time given the looming impact of a warming climate.

"We view restoring the lower Snake River as urgent and overdue. To us, the lower Snake River is a living being, and, as stewards, we are compelled to speak the truth on behalf of this life force and the impacts these concrete barriers on the lower Snake have on salmon, steelhead, and lamprey, on a diverse ecosystem, on our Treaty-reserved way of life, and on our people." stated Chairman Shannon F. Wheeler.

The Tribe has actively participated in the Endangered Species Act and National Environmental Policy Act (NEPA) litigation involving the impacts of the federal dams on the lower Snake River and mainstem Columbia River. The Tribe agreed with U.S. District Judge Michael Simon about the unique opportunity a comprehensive Environmental Impact Statement (EIS) provides—that a comprehensive EIS "may be able to break through any logjam that simply maintains the precarious status quo" while the Federal Columbia River Power System "remains a system that

'cries out' for a new approach and for new thinking" if wild Pacific salmon and steelhead are to survive their encounter with modern man.

"Today's Record of Decision (ROD) embraces an EIS that failed to provide the accurate, complete, and transparent information and analysis of the impacts of the four lower Snake River dams that are necessary for national and regional decision-makers, and that is required by law under NEPA. And today's ROD embraces a fifteen year BiOp — in the face of looming climate change projections — that requires no more protection for salmon and steelhead than the 2019-2021 Spill Operation Agreement that was merely intended to be an interim agreement — a bridge — to the development of a more significant system improvement. The ROD — and the EIS and BiOp — are unacceptable," Chairman Wheeler continued.

"We are committed to continuing to provide leadership on restoring the lower Snake River in all forums: from the halls of Congress, to our federal agency trustees and partners, to the courtroom, to the statehouses, to conversations with our neighbors, energy interests, and other river users," concluded Chairman Wheeler.

> Re: Nez Perce Tribe's Comments on the Stibnite Gold Project Draft Environmental Impact Statement

Dear Forest Supervisor Jackson:

On behalf of the Nez Perce Tribe ("Tribe"), thank you for the opportunity to comment on the Payette and Boise National Forests' ("Forest" or "Agency") Stibnite Gold Project and U.S. Army Corps of Engineers' ("Corps") Clean Water Act Section 404 review (collectively "Stibnite Gold Project" or "Project") Draft Environmental Impact Statement ("DEIS"). This transmittal letter, accompanying technical comments, flash drive containing electronic copies of citation attachments, prior submitted comments, and information generated between the Tribe and United States pursuant to our government-to-government interactions, represent the comments of the Tribe.

The Project is located entirely within the homeland of the Nez Perce people, the *Nimiipuu*, and within the Tribe's area of exclusive use and occupancy, as adjudicated by the Indian Claims Commission. On June 11, 1855, the Tribe entered into a treaty with the United States ("1855 Treaty"). In the 1855 Treaty, the Tribe reserved and the United States secured to the Tribe rights that the *Nimiipuu* have exercised since time immemorial, including the right to take fish at all usual and accustomed places, and the rights to hunt, gather, pasture, and travel. These were not "rights" that impose responsibilities on the United States. For the *Nimiipuu* they were and are a

guarantee of our ability to preserve our culture and identity that are inextricably linked to the reserved rights. These 1855 Treaty rights are the "supreme law of the land."<sup>3</sup>

The Tribe has endured immeasurable harm over the last two centuries as a result of misguided federal policies, exploitative resource extraction and land management practices, and broken treaty promises that have ignored our culture and threatened our way of life. Gold mining has played a particularly egregious and lasting role in this ignominious history of hardship and loss. Shortly after the 1855 Treaty was ratified, gold was discovered within the Tribe's homeland. Multitudes of prospectors, ignoring our treaty rights, illegally flooded our lands, stealing vast quantities of gold and other resources and befouling our pristine waters and sacred places. The United States, unwilling to enforce its treaty obligations and expel the gold-seeking trespassers, instead forced the Tribe to enter into a new treaty ("1863 Treaty"). While the 1863 Treaty retains our fishing, hunting, gathering, pasturing, and travel rights, our Reservation was substantially reduced—opening to non-Indian settlement lands from which gold and other resources had been illegally taken.

Given gold mining's legacy of dispossession and wanton destruction of our land and resources, the Tribe is committed to preventing these harms from ever again revisiting our people. When Midas Gold arrived from Canada, pursuing mining claims at the Stibnite site within our aboriginal homeland and branding itself as an environmentally-friendly mining company with promises to "restore the site" by re-mining it for gold and other minerals, the Tribe was skeptical of this dubious claim. As the original inhabitants and stewards of this land, we are widely recognized for our commitment to restoring salmon, steelhead, and lamprey, and as a comanager and partner, for our active implementation of habitat restoration and hatchery actions in the Snake and Salmon river basins. Honoring our relationship to the fish, and all animals and plants inhabiting our cherished lands and waters, is fundamental to our identity and survival as *Nimiipuu*—and will always remain our sacred and privileged duty.

The Tribe has committed thousands of hours and substantial resources evaluating the Project. The Tribe reviewed Midas Gold's Plan of Restoration and Operations ("PRO") and submitted scoping comments on July 20, 2017. In October 2018, the Tribe passed a resolution opposing the Project based on existential threats to our treaty rights and resources, cultural resources, and other interests. We have since continued to closely monitor the Project through formal and informal consultation with the Forest, emphasizing at every opportunity the Agency's obligations to protect the Tribe's treaty rights. We have also consistently urged the Forest and other reviewing agencies to provide accurate, complete, and transparent information and analyses to the Tribe and public that the National Environmental Policy Act ("NEPA") and other federal laws require for the Project.

The Tribe has carefully examined the DEIS and documents our numerous concerns with the draft in our accompanying comments. Many of the Tribe's comments, despite repeated expression and dialogue throughout this process, correlate to the Forest's refusal to acknowledge the primacy of

the 1855 Treaty as applied to this Project and take action to safeguard our treaty-reserved rights. As an agency of the United States, the Forest has a treaty-based duty, enshrined in the U.S. Constitution and supported by numerous U.S. Supreme Court decisions, to ensure that its actions, including approving the Project, do not result in harm to our rights reserved in the 1855 Treaty.

Yet, as evident throughout the DEIS, the Forest's and Corps' analysis reflects an outrageous and deeply erroneous presumption that the Tribe's treaty-reserved rights must yield to Midas Gold's Project, even if the Project results in substantial, irreparable, and lasting harm to the Tribe's treaty rights and resources for decades and perhaps longer. These unacceptable harms to our people are undisputed. The Forest arrived at these determinations in its own analysis for each action alternative in the DEIS.

Given the Forest's deference to—and as described in the Tribe's accompanying comments—inadequate evaluation of Midas Gold's Project, the DEIS is fundamentally flawed. As a result, the range of alternatives, effects, and analysis must undergo foundational revisions to comply with NEPA. Without these foundational changes, the Project will also result in violation of numerous forest plan standards under the National Forest Management Act that protect treaty-reserved fish and habitat and other values important to the exercise of the Tribe's treaty rights and protection of cultural resources. Moreover, the Corps' decision to rely on the DEIS to support a permit decision pursuant to Section 404 of the Clean Water Act for the Project without a completed application from Midas Gold or adequate notice to the public, is also premature and inadequate.

We urge the Forest and Corps to prepare a Supplemental Environmental Impact Statement ("SEIS") to address the numerous defects described in the Tribe's comments and to provide further Tribal and public comment to address the foundational defects in the DEIS. The Tribe also requests government-to-government consultation with the Forest, including an opportunity to review the Forest's written responses to all the Tribe's comments, prior to the issuance of any revised DEIS or SEIS, final environmental review, or draft decision on the Project.
