Dear Tribal Member:

When the FY 2020 audit for our casino operations was finalized at the end of January, the threshold was met to distribute the 6th per capita payment from the Tribe's Gaming Revenue Allocation Plan ("GRAP"), **on or about March 15, 2021**. The dollar amount of the distribution will be **\$532.00**, which was affected by the COVID-19 closure of casino operations last Spring. I ask that you take time to review the following information carefully.

Distributions will once again take place one of two ways: 1) a direct deposit into your bank account (must be in United States) or 2) a check mailed via U.S. mail. For those who participated in the 2019 distribution and elected direct deposit, we will automatically make your 2021 payment to the same bank account, unless you inform us otherwise. For those receiving a check, it will be sent to the mailing address currently on file with our Enrollment office, as of 1/31/2021. We encourage tribal members to receive payments via direct deposit.

A Change Form is included on the back of this letter. If your bank account or mailing address has changed in the last two years, we encourage you to update the appropriate section(s) to avoid any potential delays. Changes should be returned to the Tribe's Enrollment Office no later than March 1, 2021 by one of the methods indicated in the box in the top right corner of the form. **If you believe nothing has changed, you do not need to return any paperwork.** However, if no form is returned, and a payment is mailed to an outdated address or sent for direct deposit into a closed bank account, it could take up to three weeks to be able to replace and reissue your payment.

By law, funds allocated to a Minor (under age 18 as of 3/15/2021) must be placed into a trust account established by the Tribe, although a custodial parent or guardian may elect to receive 50% of the funds on the Minor's behalf. In choosing that option, the parent or guardian agrees to "use the funds exclusively for the health, education or welfare of the Minor." The same election choice made for children who participated in the 2019 GRAP distribution will be used once again. However, if you want to choose something different, the Change Form must be returned. If you are the custodial parent(s) or guardian(s) of a minor child enrolled subsequent to the 2019 distribution, and you would like to receive 50% of the Minor's distribution, please complete the Minor's Selection portion of the form. Otherwise, their distribution will go 100% into trust. Once placed in trust, the Minor's funds may not be accessed until his/her 18th birthday. A separate form needs to be on file for each Minor – those with a change from 2019 or those making first-time elections for recent and new Minor enrollees. Only one parent or guardian may elect to receive funds.

If you are uncertain about any aspect of this, please contact the Enrollment Office as it may require completion of an updated Change Form.
