

# Nez Perce Tribe Fish and Wildlife Commission

## 2021 Fishing Season Regulation for Columbia River Zone 6

Pursuant to the Nez Perce Tribal Code Section 3-1-11, the Nez Perce Tribe Fish and Wildlife Commission has the authority to promulgate annual and seasonal hunting and fishing regulations and prescribe the manner and methods which may be used in taking fish and wildlife. Pursuant to that authority, the Nez Perce Fish and Wildlife Commission adopted the following fishing regulation for the Nez Perce Tribe.

Columbia River Zone 6
Commercial Gillnet Fishery

John Day Pool Only – 5AM February 24 through 6PM February 26 Bonneville Pool Only – 6AM March 1 through 6PM March 5

### JOHN DAY POOL ONLY

Gear Gillnets with no mesh size restriction.

**Allowable Sales** Sturgeon from 43 to 54 inches fork length, salmon (any species), steelhead, walleye, bass, carp, catfish, shad, and yellow perch may be sold or kept for subsistence purposes. Fish landed during the open periods are allowed to be sold after the period concludes.

**Sanctuaries** River mouth and dam closed areas applicable to gillnet gear are in place.

#### BONNEVILLE POOL ONLY

Gear Gillnets with no mesh size restrictions

**Allowable Sales** Sturgeon from 43 to 54 inches fork length, salmon (any species), steelhead, walleye, bass, carp, catfish, shad, and yellow perch may be sold or kept for subsistence purposes. Fish landed during the open periods are allowed to be sold after the period concludes.

Sanctuaries: River mouth and dam closed areas applicable to gillnet gear are in effect.

**All of Zone 6 Platform and Hook and Line Fishery** 6AM, February 2 through 6PM, March 19 same rules apply as in Regulation #NPTFWC 21-032.

Not complying with these regulations may be cause for civil or criminal penalties per the Nez Perce Tribal Code.
