# **NEZ PERCE EXPRESS (LEWISTON, ID)**

Store Manager (non-gaming) NPX-22-046 (Full-Time) - The Store Manager shall oversee the management and operations of all Tribal owned stores (Nez Perce Express & Qemes Express). The Store Manager is responsible for achievement of established gross and net profit margins and the overall financial performance of the stores. The Store Manager will provide regular status reports to the NPTE Business Operations Director, NPTE Executive Officer and NPT Enterprise Board. Prepare annual sales, cost of sales, and operating budgets; review monthly, quarterly, and annual financial statements and facilitate appropriate actions to meet financial and operating goals; ensure that effective gross margins on sales are maintained; conduct financial and operations analysis when necessary. Requires an Associate's degree in Business, Accounting or closely related field. Bachelor's degree preferred. Requires five years supervisory/managerial experience in a retail environment where the fuel, tobacco, alcohol, and general merchandise is sold. Experience in multiple location retail environment.
