**Parental Consent**  
**Release of All Claims**

I, \_\_\_\_\_ the parent or guardian of \_\_\_\_\_, give permission for my child to reside in and participate in all activities and services that Nez Perce Tribe I'nit provides.

**Video surveillance** – This is to inform you that the premises at the Nez Perce Tribe I'nit is under surveillance 24 hours a day for the safety and protection of all residents and staff. Cameras are in located common areas and outside premises.

**Vehicle Policy** – Residents with a valid driver's license, current registration and insurance may keep their personal vehicle on the property; a copy of this documentation must be provided at the time intake and/or prior to driving and/or parking a vehicle on the property.

Carpooling between residences must first be approved by I' nit Coordinator and CPS caseworkers. The I' nit has transportation available for all residents to accommodate basic need transportation (i.e., school, shopping, community service, etc.)

**Curfew Guidelines** – Curfew guidelines are contingent on grades, probation, and behavior.

Ages 14-15 - **8 pm Weekdays / 9pm Weekends**                      Ages 16-18 - **9 pm Weekdays / 10pm Weekends**

**Open House Residents - 9am- 9pm**

Violation of this policy will result in your curfew extension privileges being revoked as well as any other consequences that may be necessary. \*This is a case by case basis.

In consideration of being accepted by I'nit -Teen Shelter, we being 21 years of age or older, do for ourselves and for an on behalf of our child, forever discharge and agree to hold harmless Nez Perce Tribe I'nit staff, directors, members, agents and volunteers from any and all liability, claims or demands for personal injury, sickness or death. Furthermore, we for ourselves and on behalf of our child hereby assume all risk of personal injury, sickness, death, damage, and expense as a result of participation in recreation and activities involved. Further, authorization and permission are hereby given to I'nit Staff to provide any necessary transportation, food and lodging for my child.

The undersigned further hereby agrees to hold harmless and indemnify said staff/employees for any liability sustained by said staff as the result of the negligent, willful, or intentional acts of said child, including expenses incurred attendant thereto.

We are the parents or legal guardians of this child and hereby grant permission for them to participate fully and hereby give our permission to take said child to a doctor or hospital and hereby authorize medical treatment, including but not limited to emergency surgery or medical treatment, and assume the responsibility of all medical bills, if any.

Further, should it be necessary for the participant to return home due to medical reasons, disciplinary action or otherwise, we hereby assume all transportation costs.
