RESEARCH REGULATION ORDINANCE PROCESS

To obtain a written permit:

- 1. Applicant must complete and present to the appropriate Department Manager the attached forms at least ninety (90) days prior to proposed study, survey, or research project start date.
- 2. Applicant must read and obtain a working understanding of the Research Regulation Ordinance and its contents from the Cultural Resource Program ("CRP") which has administrative oversight of the Research Permit process.
- 3. Applicant must prepare multiple copies of a brief and concise written prospectus (one page) of proposed study, survey, or research project which will be presented to the appropriate Nez Perce Tribal Executive Committee ("NPTEC") subcommittee by the Cultural Resources Director. The appropriate Department Manager or Program Director may be present if they so desire.
- 4. The CRP is tasked with a cultural knowledge review and preparation of a resolution to accompany the application packet being presented to NPTEC subcommittee by the Natural Resources Manager.
- 5. Each signatory has 14 days to review and submit approval/recommendation.
- 6. Only written permits will be official and must include the authorizing signature and Tribal resolution number.
- 7. The NPTEC sign off will be the final approval/disapproval for the request. A \$75.00 permit fee will be paid to CRP upon final approval of the request.
- 8. A copy of the final study, survey, or research project shall be provided to the Nez Perce Tribe.

Any person attempting to conduct research not specifically requested or contracted by the NPTEC or permitted pursuant to provisions of the ordinance shall be subject to any and all civil or criminal remedies available pursuant to the Nez Perce Tribe Revised Code, including but not limited to exclusion from tribal property, criminal trespass, and civil remedies provided for in the Nez Perce Tribe Revised Code.

I further attest that the information provided in the Research Permit Application is true and correct, and I understand that false information may result in denial or cancellation of a research permit.

17. Tribal Sovereignty

I understand that Tribal sovereignty is of the utmost importance when writing and publishing my research. While this study, survey, or research project was conducted following written approval of the Nez Perce Tribe, this approval is not intended to indicate that the Tribe endorses or approves of the findings/results. The Nez Perce retains their sovereignty to information, data, and historical and cultural knowledge.

NEZ PERCE TRIBE RESEARCH REGULATION ORDINANCE

Section 1: <u>Authority</u>

This Nez Perce Tribe Research Regulation Ordinance is established by the Nez Perce Tribal Executive Committee under authority contained in the Revised Constitution and By-Laws of the Nez Perce Tribe, including the amendments therein.

Section 2: Purpose

The purpose of this Research Regulation Ordinance is to regulate studies, surveys, and research projects on the Nez Perce Tribe in order to preserve and protect the rights of the Nez Perce Tribe and Tribal members, their privacy, integrity, and their interests in the results and products of such studies, surveys, and research projects.

Section 3: Permit Required

Any individual, corporation, agency or institution, whether public or private, wishing to undertake a study, survey, or research project for any purpose on the Nez Perce Tribe must obtain a permit approved through the Research Regulation Ordinance process as stated herein. This does not apply to those entities specifically requested or contracted for and by the Nez Perce Tribe.

Section 4: Written Agreement Required for Issuance of Permit

No permit will be issued for any study, survey, or research project without a written agreement with the Nez Perce Tribe (verbal agreement are not authorized agreements). The written agreement shall contain assurance of protection of individual as well as Tribal rights, methodology of the research, timeliness, study results, review opportunity prior to publication, final authorization and parameters for publication, and if product is published for profit, the percent of royalty due to the Nez Perce Tribe. A \$75.00 permit fee will be assessed and payable upon final approval of the research permit.

Section 5: <u>Information Required for Issuance of Permit</u>

No permit shall be issued to conduct any study, survey, or research project until the following information has been provided to and approved by the Nez Perce Tribal Executive Committee:

- 1. Name and signature of individual applicant or authorized agent of any corporation, agency, or institution designing to conduct or participate in the conduct of the study, survey, or research project.
- 2. Purpose of the study, survey, or research, including whether it is being conducted for profit.

- 3. Source of funding and amount of funding of the study, survey, or research project.
- 4. Methodology to be used in conducting the study, survey, or research project.
- 5. Names and qualifications of all persons authorized to be involved and/or participate in the conduct of the study, survey, or research project, whether or not those persons will actually be present on the Nez Perce Reservation during the term of the study, survey, or research project.
- 6. Dates between which the study, survey, or research project will be conducted on the Nez Perce Tribe and indication of the location of sources of information to be investigated during the term of the study, survey, or research project.
- 7. A description of the intended final product of the study, survey, or research project, and whether or not publication is intended.
- 8. How the individual, agency, or institution conducting the study, survey, or research project intends to use the results thereof.
- 9. An indication of steps to be taken to ensure the protection of the rights of individual Tribal members and their families and the rights of the Nez Perce Tribe.
- 10. A performance bond in circumstances deemed appropriate by the Nez Perce Tribe.

Section 6: Cancellation of Permit

The permit issued pursuant to this Research Regulation Ordinance is conditional and may be canceled at any time if it appears that the individual, corporation, agency, or institution conducting the study, survey, or research project has deviated from the study design approved in the granting of the permit or from provisions of the required underlying agreement upon which issuance of the permit is based.
