

How They Achieved Their Dream

The Kash Kash family worked tirelessly alongside the Mortgage Finance Assistance Program to make their dream a reality. Their efforts included:

- **Financial Discipline:** The family committed to budgeting and saving diligently, ensuring they were prepared for the responsibilities of homeownership.
- Education and Learning: They attended

 understanding of mortgages, credit management,

HOW RENT PAYMENTS INFLUENCE MORTGAGE LOANS

When envisioning your ideal new home, it's essential to consider your rent payment history, a key focus for mortgage loan officers. Here are the things they look for:

- Consistent, timely rent payments without any late fees over the past 1 to 2 years.
- Avoid using untraceable cash payments; opt for methods that clearly link payments to you such as personal check, money order, payroll deduction and, bill/auto pay.
- Received rental assistance? If possible, try to save that amount in your savings account.
- Lender will verify through Landlord Verification and bank statements.

These guidelines may minimize risk in the eyes of the lender while increasing approval odds for a mortgage loan and prevent a challenging qualification process. Climate-Ready Upgrades

UPCOMING CLIMATE-READY HOUSING UPGRADES ON THE NEZ PERCE RESERVATION

You may have heard the great news that the Nez Perce Tribe will receive \$45 million from the Environmental Protection Agency (EPA) over the next five years through two Climate Pollution Reduction Implementation Grants (CPRG). In 2024, the Tribe was awarded \$37 million in the General Competition (competing against over 200 state, local, and municipal entities) and \$7 million from the Tribes and Territories Competition. These grant projects aim to reduce greenhouse gas (GHG) emissions across multiple sectors, with initiatives focused on building energy efficiency retrofits, renewable energy projects, electric vehicle transportation networks, and tree plantings. This article highlights the upgrades that will create "climate-ready housing" on the Nez Perce Reservation.

Eighteen million dollars of the CPRG funding will go towards mitigating wildfire smoke, extreme weather events, and energy use in 650 Indigenous homes on the Reservation. Projects are expected to begin in the summer of 2025 and continue through 2029.

There will be an application process and qualifying homes will receive:

- Energy audits to evaluate the home's existing heating, cooling, and ventilation systems, identifying air leaks and areas to insulate.
- Weatherization and energy efficiency upgrades such as sealing air leaks, insulating mechanical systems and other structural components, and weatherstripping doors and windows.
- Installation of electric air-source heat pumps or mini-splits that have the dual benefit of providing heat in the winter and air conditioning in the hot months.
- HEPA-filter air cleaners to reduce pollutants in the indoor environment.

Additionally, reducing emissions and improving energy efficiency in wood-burning homes is also a priority area. Many wood stoves on the Nez Perce Reservation are more than 40 years old and are uncertified devices. To address this, 350 Indigenous homes will have their existing wood stoves replaced with new EPA-certified models. Old stoves will be recycled or destroyed. Pairing a wood stove with a heat pump has also been an effective strategy in other communities. This initiative includes EPA Burn Wise educational approaches and materials for best burn practices to promote proper wood storage, the use of dry wood, and burning small, hot fires to increase safety and efficiency, and reduce emissions.

UPCOMING CLIMATE-READY HOUSING UPGRADES ON THE NEZ PERCE RESERVATION (CONTINUED)

Lastly, an additional 300 Indigenous homes will receive solar power infrastructure upgrades, specifically home-based battery systems compatible with existing or planned solar arrays (purchased and installed with other funding sources). These solar/storage systems will reduce reliance on overhead power lines, which can go down during storms and wildfires. Onsite generation of renewable energy reduces GHG emissions and co-pollutants while creating energy resilience for residents.

Avoid Pooling in Gutters

Neglected, clogged gutters are prone to pooling water, putting undue stress on your system and causing sagging gutters

Possible Cracks in Foundation



Soil saturated from pooling water can put your foundation under additional stress, potentially causing cracks and expensive repairs



Avoid Costly Repairs

Diligently maintaining your gutter system means you're much less likely to spend hundreds or thousands of dollars on repairs over the years

Tips for Mold Cleanup



MOLD & IT'S CAUSES

Mold is a simple, common type of fungi than can be found everywhere. Any material that remains wet or moist for 24 to 48 hours can be a home for mold.

HOW TO CLEAN & REMOVE MOLD

- 1. Identify moisture source & correct it
- 2. Clean & dry the area within 24 to 48 hours
- 3. Clean with mild soap & water thoroughly dry
- Repeat anytime you see mold forming





REDUCE & PREVENT MOLD

- Use exhaust fans regularly in kitchen, bathroom, laundry room.
- Clean & dust regularly
- Regularly clean & dry walls & floors around sink, bathtub, shower, and toilets.
- Keep bed, dresser & other objects pulled a few inches from walls.
