**BASE BID:** Pursuant to and in compliance with the contract documents, the undersigned hereby certified that he/she has personally and carefully examined the Scope of Work included herein as well as sites and conditions affecting the work, proposes to furnish all labor, materials, machinery, superintendence, insurance, supplies, fees, overhead and profit, appliances, transportation, tools, equipment and other accessories/facilities/services/allowances/costs necessary and required for same.

**SCOPE OF WORK:**

1. In all ways, work will conform to the Federal, State of Idaho and Indian Health Service regulation regarding the installation of a new septic system including tank and piping.
2. Any waste material associated with the old system will be disposed of in an approved landfill. Include the cost of disposal in this bid. Verification of dumping fees must be made to the Tribe before payment will be made.

4. Work will conform to all requirements outlined in Attachment A: Indian Health Service Bid Documents and Specifications.

**COMPLETION:** Period of Performance will be 60 Days after Official Notification.

**SAFETY:** Contractor will take all safety measures to ensure that the residents, their visitors and the contractor's employees are not exposed to any safety hazards. It is the contractor's responsibility to verify and locate existing site utilities before work begins.

**BONDING:** Contractor(s) must have workman's compensation insurance and performance/payment bond in place for the total amount of the contract, before construction begins. Proof of insurance coverage must be submitted to the Tribe before work begins.

**INSPECTIONS:** The Tribe reserves the right to inspect and review each phase of the Work.

**TERO:** Contractor shall comply with all regulations of the Tribal Employment Rights Office (TERO), including Tribal wage rates. **Bids will include TERO fees** that must be paid before work begins. Contact the TERO office at (208) 843-7363 to determine fee structure and wage rates.

**ADDITIONAL CONDITIONS:** Undersigned agrees that the Tribe reserves the right to waive any and all informalities in the bidding process, or to reject or accept any or all bids or any part of a single Bid.

Bidder further agrees to abide by all Indian Preference, Affirmative Action, Labor Standards, Equal Employment Opportunity, Prevailing Tribal Wage Guidelines (available from the TERO office), Environmental Protection Agency, etc. and all requirements included in the contract documents.
