The program will provide **Wood Stove Change Outs (WSCO)** and **weatherization services** (including, but not limited to, home energy audits, sealing air leaks, exterior wall installation, window and door stripping, limited window replacement, minor roof repair, air source heat pump installs, etc.) for qualifying homes to improve indoor air quality, reduce safety hazards, and increase energy efficiency for participating households. Our goal is to reduce greenhouse gas emissions in residential homes.
